VISA Process

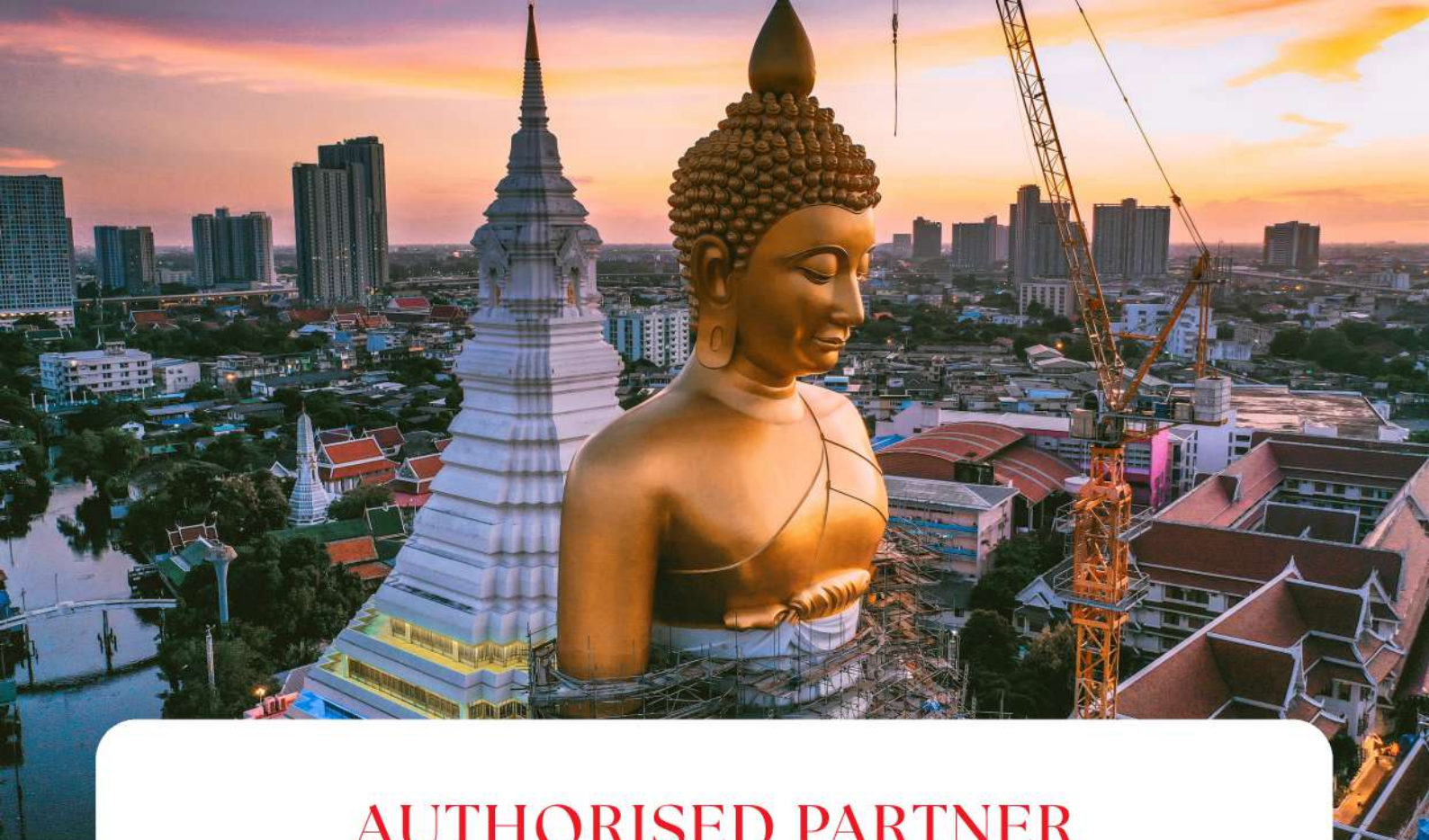

 - Purpose of attending the course
 - Personal history check
 - Application form
- 4) Guarantee Letter (Parent)
- 5) 6 months Bank Statement (Signed & Sealed from Bank Manager)
 - 1. Min Balance 85K (STUDENT)
 - OR
 - 2. Min Balance 1.75L (PARENT) (Birth Certificate of the applicant is to be MEA Attested if parent's bank statement is given)
- 6) Covering Letter – Student
- 7) No Objection Letter – Parent
- 8) Confirmed Air Ticket
- 9) Educational Certificates copy
- 10) Photo
- 11) Passport
- 12) Original PCC (Optional)

VISA Rejection: -

1. Background verification
2. If Bank transaction is irregular
3. Invalid Bonafide letter from Institute
